

Divorce Support Anonymous (DSA) Leaders Agreement

In signing this agreement you agree to the following:

- 1) Maintain integrity of \$100.00 per participant pricing for the ten-week course. To be paid to leader by the individual, church or family and friends.
- 2) The cost to leaders direct will be \$70. (\$30 used for refreshments, scholarships, leader needs)
- 3) All materials are copyright to Spirited Presentations LLC
- 4) Follow and state these guidelines to each member of the group:
 - · No advising each other
 - Maintain a safe environment, physically, emotionally, spiritually
 - Discourage any opposite sex relationships during this 10-week course.
 - Confidentiality of all personal and private information
- 5) Maintain a witness of the Lordship of Christ in your groups and in your life.
